Councillor Locke congratulated all award recipients during the Sports Hall of Fame Ceremony on June 13th.

Councillor Locke reminded everyone to be extra cautious driving during the summer months as our youth are out of school. Watch for children, pedestrians, and cyclists.

24-06-335 FCM Convention

Councillor Locke highlighted events/sessions that took place during the conference, including municipal growth framework, legislation protection for elected officials as it relates to harassment and abuse, and the City of Edmonton's adoption of Vision Zero, a traffic management and planning to prevent serious injury and fatalities.

Deputy Mayor Kieley commented on the Vision Zero initiative, noting impacts to families and communities, and her support of this work.

Mayor Aker congratulated newly elected FCM Board, wishing them well as they represent municipalities at the national level.

Councillor Rice discussed stories of harassment told by municipal elected officials during Convention, noting the difficulty it must be to endure in the community where you live.

Councillor Rice further discussed the importance of housing and infrastructure. He visited the FCM Trade Show events, promoting infrastructure and vision of affordable housing, smaller homes built of poly material.

She noted the importance to talk about negative effects of colonization, and understand impacts on our communities and Indigenous populations. 3. <u>Professional Development / Travel Request – Mayor Dave Aker – American Public</u> <u>Works Association (APWA) PWX Public Works Conference – September 8-11, 2024</u> <u>– Atlanta, GA</u>

Background

The Committee reviewed the background information regarding the above-noted request as distributed prior to the meeting. The request was supported by the Committee at their meeting of June 3, 2024, and by the Committee of the Whole at their meeting of June 18, 2024; and, in the interest of timing, the Committee was also supportive of advising the Mayor to proceed with planning the travel in the interim if necessary to avail of seat sales.

Recommendation

The Corporate Services and Public Works Committee recommends ratification of approval of the request by Mayor Aker to attend the American Public Works Association (APWA) PWX Public Works Conference in Atlanta, GA from September 8-11, 2024.

Travel Request for Mayor Dave Aker 2024 Municipalities Newfoundland and Labrador Conference <u>Gander, NL – November 7-9, 2024</u>

Recommendation

It is recommended that the travel request by Mayor Dave Aker to attend the 2024 Municipalities Newfoundland and Labrador Conference in Gander from November 7-9, 2024, be approved.

5. Request for Support of Annual Chamber of Commerce Golf Tournament

Background

The Committee reviewed a request from the Mount Pearl – Paradise Chamber of Commerce for support of their 2024 Annual Golf Tournament. The Director advised that the city supported two teams for the golf tournament last year and the Department recommended the same level of support for 2024. The Department's recommendation was supported by the Committee at their meeting of June 3, 2024, and by the Committee of the Whole at their meeting of June 18, 2024.

Recommendation

The Corporate Services and Public Works Committee recommends approval for the city to sponsor two teams in the annual Mount Pearl-Paradise Chamber of Commerce Golf Tournament for 2024.

6. <u>Housing Accelerator Fund Development Incentives</u>

Background

The availability of housing has become a major challenge within the city, region, and province. As part of the new Strategic Plan, the long-term Economic Development Strategy, and the Find Your Centre Plan, and most recently, through the Housing Accelerator Fund Program (CMHC), it is a priority to increase the city's capacity to incentivize and encourage high-density housing developments. As we are facing a province-wide crisis in housing availability, it is time to act on overcoming this challenge.

As a part of the Housing Accelerator Fund (HAF) program, City of Mount Pearl has allocated \$500,000 to be allocated for incentive programming. The following incentives are recommended, and will be packaged as a suite of offerings to prospective developers and not-for-profit entities.

Incentive 1: Multi-Unit Build Grant Program

For any housing development build with 4 units or more can qualify for a grant based on the number of units, up to a maximum of \$50,000 per project:

- \$1000 per unit if occupancy permit issued within 3 years.
- \$2000 per unit if occupancy permit issued within 2 years.
- \$3000 per unit if occupancy permit issued within 1 year.

Incentive 2: Waiver of Development Fees to Promote New Home Construction The following fees will be waived on any new high density housing builds with 4 units or more units and up to a maximum of \$50,000 per project.

- Development Permit
- Site Permit
- Building Permit Fees
- Any application or associated fees

Incentive 3: Redevelopment of Underutilized Parcels of Land

Leverage underutilized land as well as land owned by the city to promote medium and high-density development via consolidation of smaller land parcels into larger sites to unlock greater density.

• \$10,000 grant per lot to a maximum of 10 lots.

Incentive 4: Tiered Incentive Program

Encourage Mount Pearl's existing property owners to optimize their current parcel of land.

- \$20,000 to promote new accessory dwelling units in existing single-dwelling homes.
- \$10,000 for existing unapproved units to become legal.
- Eligibility under the program is one per civic address.

Incentive 5: Affordable Housing Pre-Construction Soft Cost Grant

Stimulate the commencement and preparation of affordable housing developments within the city via partial funding of soft costs related to activities outside actual construction for four or more units. This could include costs incurred for marketing, design, consultant fees, etc.

• Soft Cost Program will fund 15% of total costs or up to a maximum of \$15,000.

All funding incentives will be subject to the terms and conditions established by the city.

If these incentives are approved, the city would announce through a press release and create a branded incentive package which would be advertised and targeted at developers. The city would also host a HAF Open House to invite developers, landowners, builders, etc. to give an overview of the program and facilitate networking opportunities and introduce the city's HAF team.

The incentives as outlined above by the Corporate Services Department were supported by the Committee at their meeting of June 3, 2024, and by the Committee of the Whole at their meeting of June 18, 2024.

Recommendation

The Corporate Services and Public Works Committee recommends approval of the HAF Incentives as below, with all funding incentives to be subject to the terms and conditions established by the city.

Incentive 1: Multi-Unit Build Grant Program

For any housing development build with 4 units or more can qualify for a grant based on the number of units, up to a maximum of \$50,000 per project:

- \$1000 per unit if occupancy permit issued within 3 years.
- \$2000 per unit if occupancy permit issued within 2 years.
- \$3000 per unit if occupancy permit issued within 1 year.

Incentive 2: Waiver of Development Fees to Promote New Home Construction

The following fees will be waived on any new high density housing builds with 4 units or more units and up to a maximum of \$50,000 per project.

- Development Permit
- Site Permit
- Building Permit Fees
- Any application or associated fees

Incentive 3: Redevelopment of Underutilized Parcels of Land

Leverage underutilized land as well as land owned by the city to promote medium and high-density development via consolidation of smaller land parcels into larger sites to unlock greater density.

• \$10,000 grant per lot to a maximum of 10 lots.

Incentive 4: Tiered Incentive Program

Encourage Mount Pearl's existing property owners to optimize their current parcel of land.

- \$20,000 to promote new accessory dwelling units in existing single-dwelling homes.
- \$10,000 for existing unapproved units to become legal.
- Eligibility under the program is one per civic address.

Incentive 5: Affordable Housing Pre-Construction Soft Cost Grant

Stimulate the commencement and preparation of affordable housing developments within the city via partial funding of soft costs related to activities outside actual construction for four or more units. This could include costs incurred for marketing, design, consultant fees, etc.

• Soft Cost Program will fund 15% of total costs or up to a maximum of \$15,000.

7. <u>Recommendation for Extension to Agreement for High-Vis Clothing</u>

Background

The City's Collective Agreement outlines a provision of clothing issue items for staff, with issue items allocated as required/suited to specific positions. The acquisition of clothing issue items for the Infrastructure and Public Works Department is as per a combination of Request for Proposals (RFP) and Request for Quotations (RFQ) Agreements, with some additional items via request for three price quotes or custom ordered as required for unusual/urgent needs/sizing.

On August 24, 2021, Council approved (Minute #21-08-446) the awarding of a contract for the supply of select High-Vis Clothing (winter parkas, insulated snow pants,

rain suits, and non-insulated coveralls), to the lowest qualified bidder in response to the RFP21-013, Campbell's Ship Supplies. This duration of the Agreement was August 25, 2021 – August 24, 2023; however, there is an option to extend the Agreement for two additional one-year terms if mutually agreeable to the city and the vendor. Council, at their meeting of July 25, 2023, approved (Minute #23-07-392) the extension of the current RFP21-013 Agreement with Campbell's Ship Supplies for high-vis clothing for a one-year term, from August 25, 2023, to August 24, 2024.

Consideration of Second and Final One-Year Extension to August 24, 2025

With the pending expiration of the Agreement Extension, the Department contacted the vendor to enquire as to their interest in availing of the option for the second one-year extension from August 25, 2024, to August 24, 2025. The vendor indicated that, should the city wish to do so, they would be willing to extend the Agreement for an additional year to August 24, 2025; however, due to continuing inflation, their source pricing has increased, and this would result in some minor increases to the pricing to the city. The unit prices increase from the 2023-2024 pricing on all six items is an average of 1.96%.

The Department of Public Works recommended that the current RFP21-013 Agreement with Campbell's Ship Supplies for high-vis clothing be extended for the second and final optional one-year term, from August 25, 2024, to August 24, 2025. The Department's recommendation was supported by the Committee at their meeting of June 3, 2024, and by the Committee of the Whole at their meeting of June 18, 2024.

Recommendation

The Corporate Services and Public Works Committee recommends approval for the current RFP21-013 Agreement with Campbell's Ship Supplies for high-vis clothing to be extended for the second and final optional one-year term, from August 25, 2024, to August 24, 2025, with minor price increases (average of 1.96%) due to continuing inflation, and all other terms and conditions as per the original agreement.



Planning, Engineering and Development Committee Report

July 2, 2024

A meeting of the Planning, Engineering and Development Committee was held on June 19, 2024. Present for these meetings were:

The following items are now brought forward for the attention of the Council:

FOR DISCUSSION AND DIRECTION

1. Moffatt Road – Phase 7 <u>Request for Approval to proceed with Subdivision Development Agreement</u> <u>Marlay Construction Limited</u>

Background

The city has processed the subdivision application by Marlay Construction Limited to develop Phase 7 of the Moffatt Road Subdivision. This is the final phase of the Moffatt Road subdivision. This phase includes the development of a total of 63 single-family detached dwellings with or without subsidiary apartment with civic addresses 5 to 16 Lawn Point Avenue (even and odd numbers), 69 to 79 Moffatt Road (odd numbers only), 80 to 92 Moffatt Road (even numbers only), 103 to 119 LaSalle Drive (odd numbers only), 104 to 120 LaSalle Drive (even numbers only), 4 to 13 Iron Springs Road (even and odd numbers) and 1 to 10 St. Lawrence Place. The Planning Division issued DP22-0493 dated September 12, 2022, to approve Moffatt Road Subdivision – Phase 7 (63 lots, and a condition of the development permit is that the City enter into a subdivision development agreement with Marlay Construction Limited.

Recommendation

The Planning, Engineering and Development Committee is supportive of entering into an agreement with Marlay Construction Limited as conditioned in the Development Permit. Public Council to ratify the Subdivision Development Agreement with Marlay Construction.

2. 43 Greenwood Crescent - Nickel Properties Inc. - Residential Intensification <u>Proposed 24 Unit Row Dwelling Development</u>

Background

The City is in receipt of an application by Nickel Properties Inc. to develop a twenty-four (24) unit row dwelling development at 43 Greenwood Crescent. The proposal consists of six (6) buildings, comprising of both single-storey and two-storey units.

As per Section 4.17 and 4.18 of the City's Development Regulations, a notice of the application was posted to the City's website, and was published in The Telegram on Saturday, May 4, 2024. Notice was also circulated to 248 property owners within the 150-metre radius as well as all residents of Greenwood Crescent, Clover Brae Crescent, Goldeneye Place and Harlequin Crescent, via Canada Post on May 6, 2024, in addition to the Member of Parliament, two (2) MHAs, and the Mount Pearl-Paradise Chamber of Commerce. There was a Correction Notice issued due to a typographical error, but the Correction Notice did not impact the required procedures for public notification and briefing sessions as per 4.18 of the Mount Pearl Development Regulations 2010. Prior to Council deciding on the application, comments from the public were to be submitted in writing no later than 12:00 noon, Friday, May 17, 2024.

As of that date, 5 written submissions were received by the City.

The Briefing Session was held on the evening of May 22, 2024, and was attended by fourteen people comprised of residents, the developer, city staff and Councillors.

In summary the following concerns were brought forth:

- discontent with the proposed changes to their established neighbourhood
- disruption to the quiet and private nature of their street
- increased traffic
- considerations should be given to installing a traffic light at the intersection of Goldeneye Place and Topsail Road, left turfing from Goldeneye unto Topsail Road is very difficult
- increased noise
- what is the ownership model
- potential negative impacts on property values
- loss of mature trees, which not only contribute to the area's aesthetic appeal but also its environmental quality
- proposed development does not conform to Regulation 6.33 Residential Intensification Project

Recommendation

The Planning, Engineering and Development Committee has reviewed the application and recommends the application be approved and a Development Permit be issued subject to the conditions as outlined below:

- 1. St. John's Regional Fire Department
- 2. City of Mount Pearl Inspection Services
- 3. City of Mount Pearl Finance Division
- 4. City of Mount Pearl Planning Division
- 5. Water Resources Management Division (Government of Newfoundland and Labrador)
- 6. Submission of the Condominium Agreement
- 7. Construction of a permanent privacy fence
- 8. Submission of a detailed landscaping plan illustrating the preservation of existing mature trees
- Any future heat pumps, mini-split heat pumps, air conditioners or external fans forming part of the residential buildings shall meet regulation 6.16 Heat Pump, Mini-Split Heat Pump, Air Conditioner, or External Fan as per the Mount Pearl Development Regulations 2010
- 10. Any disturbance within the Conservation Zone for necessary infrastructure servicing to be re-landscaped

3. Community Centre, Splash Pad, and Ice Surface/Path Request for Change Order #3 – Remedial Action Plan

Background

A Supplemental Environmental Site Assessment was recently completed for the project site. In compliance with the recommendations of this assessment, a Remedial Action Plan including oversight of the site remediation is being implemented.

Recommendation

The Planning, Engineering and Development Committee recommends approval of Change Order #3, Remedial Action Plan, for the amount of \$11,996.50 + HST to facilitate the timely execution of the Remedial Action Plan, ensuring compliance with environmental standards.

4. 20 Bannister Street Demolition Order

Background

The property and dwelling at 20 Bannister Street has existed in a dilapidated state for a number of years. The City has continually tried to enforce maintenance of the property to no avail. Multiple communications to the property owner have been undertaken, and notices and orders have been issued to remedy the deficiencies noted to no avail.

Due to the current hazardous condition of the dwelling, and the heightened safety risk the property and dwelling is causing, the dwelling is now required to be demolished.

Recommendation

The Planning, Engineering and Development Committee recommends that Council authorize the Chief Administrative Officer to issue an Order to the property owner of 20 Bannister Street, Mount Pearl, to remedy the hazardous condition of the property by the demolition and removal of the dwelling and all other structures on the property within 30 days of the Order being served.

DEMOLITION ORDER

This Order is pursuant to the City of Mount Pearl Act, RSNL 1990, C-16, the Mount Pearl Building Regulations 2019, and the Occupancy and Maintenance Regulations.

TAKE NOTICE that it has come to the City's attention that the property located at 20 Bannister Street is in such a state of disrepair that:

- 1. A City inspector was on site on April 3, 2019, and a deficiency notice was left at the property.
- 2. On June 19, 2019, an Order was issued to have the various deficiencies identified in the aforementioned deficiency notice addressed. This Order was not complied with and the City was required to rectify the deficiencies.
- 3. A City inspector was on site twice in July 2021 and deficiency notices were left at the property. The identified deficiencies have not been rectified.
- 4. A City inspector was on site on January 31, 2023, and confirmed that the property suffers from the deficiencies identified in the attached deficiency notice, including, but not limited to interior water damage, compromised interior walls, a structurally compromised chimney, a compromised exterior wall(s), crumbling foundation, broken windows, rot, mold and deterioration, and a hole in the roof.
- 5. A third-party inspection of the property was conducted by an Inspector with the Fire Prevention Division of the St. John's Regional Fire on January 31, 2023, which confirmed that the property is especially liable to fire or the spread of fire and is situated so that it would endanger another structure or property. The Inspector recommended that the property be demolished.
- 6. A Direction to undertake all work necessary to repair the identified deficiencies was issued, served and posted on the property on February 10, 2023. A copy of the St. John's Regional Fire

Department's recommendation was included with the Direction. Repairs were to be carried out by March 10, 2023.

- 7. The City has received several complaints from residents regarding the condition and state of disrepair of the property. Rodents have been observed in and around property on a regular basis.
- 8. The Legislative Officer- City Clerk spoke to the property owner on September 21, 2023 by telephone and advised of the state of the property/dwelling. The property owner stated that he was living at a separate address and periodically visited the property.
- 9. The Legislative Officer-City Clerk further advised the property owner of the City's plan to issue a demolition order and to complete the demolition should the property owner fail to comply with the order. The property owner was to obtain quotes and an expected timeframe for the demolition from a qualified contractor and advise the Legislative Officer- City Clerk of same. The property owner has been unresponsive to telephone calls and voicemail messages since the end of September.
- 10. On November 28, 2023, City Council approved a Demolition Order. The order was sent via registered mail on November 29, 2023 per section 238 of the City of Mount Pearl Act.
- 11. On May 16, 2023, the registered mail was returned to the City. Canada Post confirmed that the recipient refused the registered mail at the time of delivery.
- 12. On July 2, 2024, City Council approved a second Demolition Order to be posted on the building at the property on 20 Bannister Street for 30 days.

TAKE NOTICE that as a result of the foregoing the property is considered to be i) in a dilapidated state, ii) unfit for human habitation, or the other use for which it is being used, iii) a public nuisance, iv) a public safety concern and/or v) non-conforming to City standards, contrary to the City of Mount Pearl Act, the Mount Pearl Building Regulations 2019, and the Occupancy and Maintenance Regulations.

AND FURTHER TAKE NOTICE THAT THE CITY NOW ORDERS, in accordance with section 238(2) of the City of Mount Pearl Act, section 55 of the Mount Pearl Building Regulations 2019, and section 42(1)(b) of the Occupancy and Maintenance Regulations, you to pull down, remove or otherwise destroy the building and return the site to its original state within 30 days of the date of this Order.

Failure to comply with this Order will result in the City making the necessary arrangements to carry out this Order through its officers, agents, employees or contractors without further notice. In the event that the City carries out this Order, all associated costs will be your responsibility and collected from you as a civil debt.

You have the right to appeal this Order. The appeal fee of \$200.00 plus HST (\$230.00) must be submitted to the Secretary of the Regional Appeal Board c/o the Department of Municipal and Provincial Affairs, by hand delivery or mailed to P.O. Box 8700, St. John's, NL, A1B 4J6 within 30 days of the date that you receive, or are considered as having received, this Order. If the appeal and a fee are not submitted within this time limit, your right to appeal is considered to be forfeited. You should also note that any interested person also has the right to appeal this Order within the 30-day appeal period.
