#### **PROCLAMATIONS**

#### 24-09-496 Declaration in Support of the Rights of Indigenous Peoples

Mayor read aloud the declaration. City of Mount Pearl is committed to fostering respectful and collaborative relationships with Indigenous Peoples within the City and beyond, and acts in support of the rights of Indigenous Peoples, particularly Urban Indigenous Peoples in the metro region.

Justin Cambell, First Light of Advocacy, was in attendance. Mr. Cambell spoke about the work of First Light in Mount Pearl and the metro area, including their mission, First Voice Community Action Plan – Our Shared Vision, 42 Calls for Change. He thanked City Council and staff for their support.

Mayor Aker, Deputy Mayor Kieley, and Council signed the declaration, committing to being a place where the inherent rights of the Indigenous Peoples of Newfoundland and Labrador, including urban Indigenous Peoples, are respectfully recognized and actively supported by all. The City strives to build an ever more inclusive Community where all residents recognize and value the diverse histories, cultures, and traditions of Indigenous Peoples.

#### 24-09-497 Childhood Cancer Awareness Month

The Mayor read aloud and signed the proclamation, on behalf of all Council, declaring September 2024 as Childhood Cancer Awareness Month in the City of Mount Pearl.

In attendance were Wendy Chaulk and her son Andrew Chaulk. Wendy and her husband, Dean, were both Vice President/President of the Candlelighters for ten years between 1998 to 2008. They moved between both positions as they were only permitted to a two-year term as President. Dean was also Camp Director for two years. Their son, Andrew, is now living beyond childhood cancer.

Ms. Chaulk discussed the work of the Candlelighters, supporting families and children living with cancer, and told her family's journey and story of her son's battle with cancer, and living with the effects of cancer. She discussed her appreciation of Mount Pearl, and residents who provided their support to her family; and she thanked Mayor and Council for their support of the Candlelighters. Council thanked Wendy and Andrew for attending this evening's meeting and sharing their story.

#### 24-09-498 Mount Pearl Arts Week

Mayor Aker read aloud and signed the proclamation declaring the week of September 22 to September 29, 2024 to be Arts Week in the City of Mount Pearl.

In attendance was Christine Hennebury from the Association for the Arts in Mount Pearl. Ms. Hennebury provided a history of the work of the Association, leading up to Arts Week, which provides an opportunity for artists to meet. She provided information as to upcoming events, and encouraged everyone to join. Council thanked Ms. Hennebury for attending this evening's meeting, appreciating the variety of programs offered. Ms. Hennebury thanked Council and staff for their support.

#### 24-09-499 Ovarian Cancer Awareness Month

Mayor Aker read aloud and signed the proclamation declaring September 2024 as Ovarian Cancer Awareness Month in the City of Mount Pearl.

Councillor Fry spoke to the proclamation, commenting on the work of Women of Hope's Founder Susan Glynn, who dedicated her time in raising awareness, as she herself, battled ovarian cancer and has since passed away.

Council recognized Susan and those living with, and battling, ovarian cancer. Council thanked Councillor Fry for advocating and bringing this forward on Susan's behalf, further noting the importance of recognizing symptoms, being aware, and the importance of early detection.

#### 24-09-508 2 Stapleton Road (Former Pool) - Notice of Motion - Proposed Rezoning

A Notice of Motion was read aloud by Councillor Antle.

In accordance with Section 39 of the City of Mount Pearl Act, RSNL, 1990, C-16, Take Notice That, in accordance with Council's Rules of Procedure, at a Regular Public Meeting of Council, Councillor Antle moved an amendment to the Mount Pearl Development Regulations and the Mount Pearl Municipal Plan, if enacted will:

## 1. Mount Pearl Development Regulations Amendment Number 77, 2024

Rezone land at civic # 2 Stapleton Road (former municipal pool site) and civic # 173,175-177A Park Avenue from the Open Space (OS) Zone and the Residential-Medium Density (RMD) Zone to the Residential-High Density (RHD) Zone; and,

#### 2. Mount Pearl Municipal Plan Amendment Number 29, 2024

Redesignate land at civic # 173 and 177A Park Avenue from the Open Space (OS) Designation to Residential (RES) Designation.

The purpose of these amendments is to provide Council with the authority to consider proposals for approval to develop on the subject property residential housing which may be in the form of Double Dwellings, Row Dwellings, dwelling units in an Apartment Building or similar. Such development would be subject to compliance with the

requirements of the Mount Pearl Municipal Plan and the Mount Pearl Development Regulations.

Council discussed that this is a notice to the public that staff are undertaking an amendment to rezone City land to accommodate future residential development. Regulatory next steps were confirmed, including public hearing and information session taking place later this Fall.

#### 3. Signing Authority for Cheques or Orders on the City's Bank Account

#### Background

Pursuant to section 98 of the City of Mount Pearl Act, which designates the city manager or city clerk as counter signer for all cheques or orders withdrawing money from the City's bank account, the city hereby designates Stephanie Walsh, as City Clerk appointed under section 68 of the Act, as signing authority with CIBC bank.

#### Recommendation

It is recommended that approval be granted to authorize Stephanie Walsh, as City Clerk appointed under section 68 of the City of Mount Pearl Act, as designated banking counter signing authority.

### 4. Ultimate Recipient Canada Community-Building Fund Administration Agreement 2024-2034

#### Background

The city is in receipt of the Ultimate Recipient Canada Community-Building Fund (CCBF) Agreement for signature. This agreement outlines the roles and responsibilities of the Ultimate Recipients and the Government of Newfoundland and Labrador and to confirm the city's allocation for 2024 to 2029. The second five years of funding (2029 to 2034) will be determined based on the 2026 census. The deadline for return of the signed agreement is September 30, 2024; however, given the short timeline, staff have arranged for a deadline extension to October 2, 2024.

#### Recommendation

The Corporate Services and Public Works Committee recommends that the Ultimate Recipient, City of Mount Pearl, approve the City entering into the Ultimate Recipient Canada Community-Building Fund Administration Agreement 2024-2034, with the Province of Newfoundland and Labrador (the province), as represented by the Minister of Municipal and Provincial Affairs, outlining the roles and responsibilities of the Province and the City. The City accepts the funding, totaling \$5,399,397 for 2024-2029, to be disbursed in accordance with the Agreement and outlined below.

#### 5. Façade Improvement Program Application Recommendation

#### Background

The City has received an application for the Façade Improvement Grant Program. Applicants who meet the criteria can receive up to 50% of total project costs up to a maximum of \$10,000. The judging and selection committee has reviewed, scored, and evaluated each application based on the project criteria and the submission criteria. The building at 1035 Topsail Road is currently occupied by business Venture Fireplace (since 2009). The proposed project will aim to restore siding, windows, doors, and front building façade, to improve the look and provide a more modern appearance and make it more attractive to the current tenants and future business opportunities. This project meets the criteria outlined in the program guidelines.

The Corporate Services Department recommended approval of a grant in the amount of \$9,100.00 for 1035 Topsail Road, and the Committee supported this recommendation at their meeting of August 27, 2024, and the Committee of the Whole supported the recommendation at their meeting of September 17, 2024.

#### Recommendation

The Corporate Services and Public Works Committee recommends that the Façade Improvement Program Grant application by the property owners of 1035 Topsail Road be approved in the amount of \$9,100.00.

#### 6. FCM's GMF Funding Application for Growing Canada's Community Canopies

#### Background

The Federation of Canadian Municipalities (FCM)'s Green Municipal Fund (GMF) has a \$291M initiative called Growing Canada's Community Canopies (GCCC) that supports planting trees across the country, contributing to climate action.

Staff have reviewed the GCCC application requirements, noting Council's required support as 50% of gross project is to be paid by the city. The Public Works Department recommended support for the city to make an application for funding for projects in line with the Urban Forestry Plan, including a budgetary commitment for 50% of the cost of proposed projects; and the Department's recommendation was supported by the Corporate Services and Public Works Committee at their meeting of September 16, 2024, and by the Committee of the Whole at their meeting of September 17, 2024, with a 2025 budget commitment of \$200,000 and work to be carried out over 2024 and 2025.

Given the time sensitivity to allow for meeting the application deadline of October 15, 2024, the Committee of the Whole authorized staff to proceed immediately with the pre-application process, with the matter to come forward for ratification approval at the October 1, 2024, Council meeting.

#### Recommendation

The Corporate Services and Public Works Committee recommends that ratification approval be granted for the city's contribution to projects in keeping with the city's Urban Forestry Plan to increase the city's tree canopy via an application to the FCM's GMF Growing Canada's Community Canopies (GCCC) funding program, with an estimated total projects cost of \$400,000 (including HST), pending funding approvals under a 50/50 cost-sharing under the GCCC funding program, and the city's contribution in the amount of \$200,000 (including HST), committed under the 2025 budget and to be carried out over 2025 and 2026 in the areas of Old Placentia Road (Sagona Avenue to Ruth Avenue and Richard Nolan Drive to Commonwealth Avenue).



#### FOR DISCUSSION AND DIRECTION

## 1. 60-62 Glencoe Drive Stormwater Repair

#### **Background**

In 2017, the City of Mount Pearl entered into an easement and access agreement with Sea-Force Technologies Inc. (Grantor) at 60-62 Glencoe Drive. The city required an easement on a portion of the property for the purpose of rerouting an existing storm water system in the rear of the property. This was approved at the July 18, 2017, Committee of the Whole meeting and executed on December 6<sup>th</sup>, 2017.

On December 7<sup>th</sup>, 2023, Parts for Trucks received a development permit for development of 60-62 Glencoe Drive. The development permit outlines the city's responsibility to carry out the work necessary to supply and install piping of the swale and/or storm water system in the easement area and feed into the existing piped storm system on Glencoe Drive.

Planning, Engineering and Development has received four quotes to complete this work, with the lowest qualified bidder being Modern Paving Ltd.

#### **Recommendation**

The Planning, Engineering and Development Committee recommend that the city award the work for stormwater repair at 60-62 Glencoe Drive to Modern Paving for the amount of up to \$195,300 (plus HST).

## 2. SERESCO AHU Service Contract Contract Extension Recommendation

#### **Background**

In June 2021, the City finalized negotiations with Dehumidified Air Services for Sole Source Service Agreement for the Summit Center SERESCO AHU. In November 2021 Council awarded the sole-source contract be approved for the initial three-year term, with two, one year extension available if mutually agreed upon by both parties. Contract cost for year 1 is \$21,735.00 (HST Included) with a 2% increase for each additional contract year.

For contract years, two and three, the cost increased 2% annually with the annual cost totaling \$22,164.88 & \$22,613.60 (HST Included) respectively.

#### Planning, Engineering & Development Department

The Manager of Facilities Management consulted with Dehumidified Air Services regarding the potential extension, and they agreed to extend the contract for an additional one (1) year at the same terms and conditions of the existing contract at the City's discretion. Dehumidified Air Services offered a discount over previous years costs, offering the same service for the 1-year extension for a total sum of \$21,850.00 (HST Included)

#### **Recommendation**

The Planning, Engineering & Development Committee recommends the extension of the existing Sole Source Service Agreement for Summit Center SERESCO AHU (SS-21-031) with Dehumidified Air Services for an additional one (1) year for the period of January 1, 2025, to December 31, 2025, for the annual bid amount of \$21,850.00 (HST Included) at the same terms and conditions of the existing agreement.

#### 3. Building & Occupancy Permit Listing | August 26 - September 06, 2024

The Planning, Engineering and Development Committee recommends that the residential and commercial building permits issued for this period, showing a total construction value of \$2,995,150.00 be approved, and further that the occupancy permit list be accepted as presented.
